1. Other services

Bus transportation

Supplementary transport

Bus transportation, if it is not necessary for airport operation purposes and is explicitly requested by an airline, is invoiced at CHF 120.- for maximum half an hour and 70 CHF per additional quarter of hour.

Firearms

Escort of hold luggage (not conforming to the Regulation) containing firearm(s)	1 to 3 arms (and munitions) : Lump sum CHF 200.00 per escort from 4 firearms (and munitions) : Lump sum CHF 400.00 10 + firearms: On quotation
Protection (storage) of hold luggage (not conforming to the Regulation) containing firearm(s)	Lump sum CHF 50.00 per day, minimum CHF 50.00.

Priority Lane

Geneva Airport offers the airline the non-exclusive possibility of using the “priority-lane” access for its premium passengers* in exchange for the payment of a fee.

The Priority Lane is located on the “Departure” level of the main terminal building of the airport. Passengers will be able to access the CSC through an automatic security gate. When passing through, the scanner will read the barcode on the passenger’s boarding card.

The barcode must include a fast-track flag according to IATA Resolution 792 - Bar Coded Boarding Pass Standard.¹

Geneva Airport sends a monthly invoice to the airline based on the actual number of passengers who have used the “priority-lane” access.

Use of cargo facilities and premises²

Rates for cargo handling agents only

For the use of cargo facilities and premises (e.g. refrigerated rooms, etc.), a fee of CHF 0.01 is levied per kilogram of import cargo (customs cleared) originating from a flight or from truck freight.

Airport Information and Management System (AIMS/AOS)

Rates for handling agents only

A charge is levied for each flight published on the airport information and management system.

Cancelled flights are published and charged.
